Web Page: Officer Hayes stated that everything was in place (software, etc.) just needed to get with Sam (City IT department) to come over and train Jeannette, Wally, and himself on how to access the folders and input information. The page should be up and running in a couple of months.

Budget: Mr. Russell reported that he had changed the Optimist donation from \$1000 to \$1150. Reminder that this money will not actually change hands. The optimist club is doing all the work. Also with the request going out in the newsletter for donation he added an additional \$500. Mr. Howe was going to check again and see if we can start to collect donations under the 501.

Reports from Officer Hayes and Sgt. White:

After the last board meeting Officer Hayes developed a training program for Captains. Officer passed around a copy of the training for the board to look at. He is going to be putting the information into a Power Point program and presenting it to Captains and people interested in the captain position.

Sgt. White said that he was putting an article in the newsletter asking for Neighbor Hood watch members for suggestion/ questions of how Neighborhood watch can be more effective.

Sgt. White also committed that Officer Hayes will have an intern assigned to him for the summer. The plan is to have this person doing nothing but Neighborhood Watch activities.
