### **President's Report**

- May 17<sup>th</sup> inventory took about an hour. Full inventory is complete and updated after the training session at Thornbrook.
- Meeting with Andy Muscato on Jun 3
  - Proposing that we consolidate the "Ice Cream with a Cop" with National Night Out the Ready Festival, Sep 18 at Cosmos Park. Could do a National Night Out in the fall if the neighborhoods request it. Need to seek feedback from the neighborhoods.
  - We requested that CNW have a specific spot, across from Lamb Shelter to make us stand out and not be combined with the other organizations.
  - Food trucks are always at the Ready Festival.
  - We will try to get ice cream.
  - o Have the emergency services staff share a tent with us.
  - o Perhaps reserve the other shelter, Berford, for CNW neighborhoods.
  - Canines, bearcat
  - Need to have the CNW be a 'headliner'.
  - o 90 days prep notification to the neighborhoods.
  - Hoping to get feedback from Andy in a week.

- \$5K reimbursement from CPD Keith provided the documentation for about \$8K in expenditures. Herb will pull \$5K of expenses and submit.
- June 30 at 11:00 at Shelter Insurance, presentation of Certification of Appreciation. Outside. Shirt event. Herb will speak about CNW background and dependencies upon donations. Asking Ryan, PIO, to reach out to media for publicity.

### Vice President's Report - Jeff

- Researching the acquisition of new computers for officers. Standard is to replace every 3-5 years. MS is ending their grant for MS Office in July. Do not know if there is a replacement program. If not, we will need a grant.
